➤ **Educational Support Program for Poor and Orphaned Children** **“A Nation that Prioritizes Education Cannot Be Defeated” – Deputy Commissioner Baramulla**

1st April 2026: Human Aid Society organized a special educational support program in Baramulla under its long-running education and welfare initiative. During the event, stationery items, school uniforms, bags, notebooks, and other educational supplies were distributed among nearly 80 poor and orphaned children belonging to economically weaker families. The program was attended by distinguished guests including Syed Fakhruddin Hamid, Neha Jain, and Altaf Hussain Mosvi. The visiting officers interacted warmly with the children, listened to their educational and social concerns, and assured all possible assistance through different government welfare schemes and educational support programs.



While addressing the gathering, the Deputy Commissioner emphasized the importance of education by stating that “A nation that prioritizes education cannot be defeated.” He appreciated the continuous efforts of Human Aid Society in supporting underprivileged children and strengthening the educational foundation of society.

On this occasion, Human Aid Society reaffirmed its role as a bridge between the administration and the public, ensuring that every deserving child receives access to education, dignity, and opportunities to pursue their dreams.

For the last 29 years, the organization has remained actively engaged in educational and humanitarian services across Jammu & Kashmir. Although several charitable initiatives receive outside support, the educational sponsorship program is being run entirely through local community contributions and donations. Due to these sustained efforts, many sponsored students have successfully become doctors, engineers, teachers, and professionals in various fields, reflecting the positive and effective use of public trust and charitable support.

➤ **Donation of Rare Mahatma Gandhi Volumes to Government Women’s College Baramulla** **Promoting Research, Knowledge, and Educational Excellence**

7th April 2026- Continuing its commitment towards education and intellectual development, Human Aid Society donated 47 rare and valuable volumes related to Mahatma Gandhi to Government Women’s College Baramulla. The books were formally presented by the Administrative Officer of Human Aid Society, Rafiya Rashid, to Prof. Dr. Neelofar Bhatt. These books, which are considered rare and difficult to procure in the present time, had been carefully preserved by the organization for many years. The



collection contains valuable material concerning the life, philosophy, teachings, and contributions of Mahatma Gandhi, one of the most influential leaders of India's freedom movement.

The purpose of donating these books to the college library is to facilitate students, scholars, and researchers in accessing authentic historical material and promoting academic research on Gandhian thought and philosophy.

Human Aid Society has consistently promoted educational growth by donating children's literature, historical books, and academic resources to different educational institutions across North Kashmir. These efforts aim to strengthen reading culture, broaden intellectual understanding, and improve access to quality educational material among students and young researchers.



This initiative represents another important milestone in the organization's mission to promote education, awareness, and research-oriented learning for future generations.

➤ **Strengthening Rural Livelihoods through Mini Poultry Farm Initiative
In Collaboration with Indian Development Service (IDS)**

12th April 2026-As part of its rural livelihood and poverty alleviation programs, Human Aid Society, in collaboration with Indian Development Service, launched a Mini Poultry Farm Initiative in border villages of Tehsil Uri. During field visits conducted by the Human Aid Society team, severe poverty, unemployment, and economic hardships were observed among families living in remote border areas. In response, the organization initiated this livelihood support program to create sustainable income opportunities for vulnerable households.



In the first phase of the project, 25 economically disadvantaged families were identified and selected as beneficiaries. Each selected family will receive high-quality laying hens to help establish small household poultry units capable of generating regular income through egg production and poultry farming.

The initiative is designed not only to provide immediate economic relief but also to encourage long-term self-reliance among rural families. Beneficiaries will receive guidance and support to gradually expand their poultry activities into larger and more sustainable units in the future. This program is expected to strengthen household incomes, improve food security, create local employment opportunities, and contribute positively towards the economic development of border communities in the Uri region.

Sewing Support, Medical Assistance, and Housing Rehabilitation

Dated-15-04-2026- During a recent humanitarian visit to a remote border village in Tehsil Uri, Human Aid Society identified a highly vulnerable and financially distressed family living in extremely difficult conditions. After assessing the family's situation and urgent needs, the organization extended comprehensive humanitarian support aimed at restoring dignity, stability, and hope to the affected household.

As part of the assistance, Human Aid Society provided a complete sewing kit to a young girl of the family to help her develop vocational skills and establish a source of livelihood from home. The sewing package included a sewing machine, stitching materials, essential tailoring accessories, fabric-related tools, and other items required for basic tailoring work. The initiative was aimed at empowering the girl economically and enabling her to contribute towards supporting her family through self-employment and skill-based income generation.



In addition to livelihood support, the organization also arranged monthly financial assistance for a seriously ill member of the family to help cover medical and household expenses. Recognizing the family's poor living conditions, Human Aid Society further took responsibility for the renovation and repair of their damaged house to ensure a safer and more dignified living environment.

This humanitarian intervention reflects the organization's continued commitment to supporting vulnerable communities living in remote and conflict-affected border areas through practical, compassionate, and sustainable assistance initiatives.

Conclusion

Human Aid Society continues to remain committed to its mission of humanitarian service, educational support, livelihood development, and community welfare across Jammu & Kashmir.
